

ORDINANCE No. 7499

**AN ORDINANCE AMENDING ORDINANCE NO. 7469 PASSED
DECEMBER 20, 2012 TO MAKE APPROPRIATIONS FOR
CURRENT EXPENSES AND OTHER EXPENDITURES OF
THE CITY OF DEFIANCE, OHIO, DURING THE PERIOD OF
JANUARY 1, 2013 THROUGH DECEMBER 31, 2013.**

WHEREAS, the City Finance Director has determined that additional appropriations are necessary to provide for expenditures; and

Ordinance No. 7500

AN ORDINANCE AMENDING THE DISTRICT MAP TO REZONE LANDS LOCATED AT 2000 NORTH CLINTON STREET

WHEREAS, On January 21, 2013, the Planning Commission recommended that all lands described by the Petition for Amendment of the District Map filed by Joseph P. Steyer be re-zoned from the B-4, Community Shopping Center, to B-3, Highway and General Business, in accordance with owner's Petition; and,

WHEREAS, On April 16, 2013, Council conducted a Public Hearing as required by statute and general Ordinances and concurs with the recommendation of the Planning Commission;

Now therefore, be it enacted by the Council of the Municipality of Defiance, Ohio, that:

Section 1: All lands described by the Petition for District Map Amendment filed by Joseph P. Steyer are hereby Zoned B-3, Highway and General Business, in accordance with the Recommendation duly adopted by the Planning Commission on January 21, 2013.

Section 2: The Clerk of the Planning Commission is directed to make all necessary changes to the District Map needed to accurately reflect the change in District designation effected by this Ordinance.

Section 3: It is found and determined that all legislative actions pertaining to the adoption of this Ordinance were taken in Public Session and that all deliberations that affected or influenced any such legislative act, including all deliberations in Committee, were conducted in Public Session duly convened in accordance with law.

Section 4: This Ordinance shall be effective from and after the earliest date permitted by law.
