

Ordinance No. 7691

AN ORDINANCE AUTHORIZING REPLACEMENT OF FOUR ZERO TURN LAWN MOWERS

WHEREAS, four mowers are scheduled for replacement in 2015 and adequate provision has been made in the 2015 annual budget for the purchase of replacement equipment;

Now therefore, be it enacted by the Council of the Municipality of Defiance, Ohio, that:

Section 1: The City Administrator is authorized to purchase: one John Deere model Z920R commercial mower; two John Deere model Z930R commercial mowers; and one John Deere model Z950R commercial mower and all optional and auxiliary equipment specified by the product descriptions detailed in Deere & Company quotation #10790630 at the prices therein established through the Ohio Department of Administrative Services Cooperative Purchasing Program. The City Administrator is further authorized to sell the 2006 ExMark, 2009 ExMark, 2011 John Deere Model Z925A and 2011 John Deere Model Z950A mowers by trade-in allowance at the prices established by the aforesaid quotation.

Section 2: The City Finance Director is authorized to pay \$5,350 of the net purchase price from Line 403-901-678-090 and \$16,100 of the net purchase price from Line 403-901-978-101 of the 2015 annual budget.

Section 3: It is found and determined that all legislative actions pertaining to the adoption of this Ordinance were taken in Public Session and that all deliberations that affected or influenced any such legislative act, including all deliberations in Committee, were conducted in Public Session duly convened in accordance with law.

Section 4: This Ordinance shall be effective on the earliest date permitted by law.

ORDINANCE NO. 7692

AN ORDINANCE AUTHORIZING THE PURCHASE OF ONE JOHN DEERE MODEL 1575 TERRAINCUT COMMERCIAL MOWER, MOWER DECK, SNOW BLOWER, SNOW PLOW AND ROTARY BROOM AND DECLARING AN EMERGENCY

WHEREAS, The 1992 John Deere model F935 commercial lawn tractor is scheduled for replacement due to age and condition and provision was made in the 2015 annual budget for the purchase of replacement equipment;

Now therefore, be it enacted by the Council of the Municipality of Defiance, Ohio, that:

Section 1: The City Administrator is authorized to purchase one John Deere Model 1575 Terraincut commercial lawn tractor and necessary attachments consisting of: one 72" commercial side discharge mower deck, one 60" two stage snow blower, one 60" hydraulic front blade and one 60" rotary broom conforming to the equipment specifications and product descriptions detailed in Deere & Company quotation #10319490 and at the prices therein established through the Ohio Department of Administrative Services Cooperative Purchasing Program. The City Administrator is further authorized to sell one 1992 John Deere model F935 commercial lawn tractor by trade-in allowance at the \$3,499.64 price established by the aforesaid quotation.

Section 2: The Finance Director is authorized to pay the net purchase price of \$40,135.00 from appropriated funds allocated to the purchase by Line 403-901-978-091 of the 2015 annual budget.

Section 3: It is found and determined that all legislative actions pertaining to the adoption of this Ordinance were taken in Public Session and that all deliberations that affected or influenced any such legislative act, including all deliberations in Committee, were conducted in Public Session duly convened in accordance with law.

Section 4: This Ordinance is declared to be an emergency measure necessary to preserve the health, safety or welfare of the community for the reason that immediate delivery of the equipment is required to conduct snow removal operations necessary to the maintenance of pedestrian sidewalks on bridges and pedestrian sidewalks fronting municipally-owned lands. As such, this Ordinance shall be effective immediately upon passage by an affirmative vote of not less than 5 Members of Council and approval of the Mayor.
