
IN RE: BOND SCHEDULE FOR DEFIANCE MUNICIPAL COURT

The herein adopted BOND SCHEDULE shall be prominently posted in the Criminal/Traffic Division Office and certified copies shall be provided to all law enforcement agencies having jurisdiction in Defiance County, Ohio.

This BOND SCHEDULE shall supersede and take the place of any other bond schedule ordered by this Court.

For the purposes of this schedule, the following definitions shall apply:

1. **Minor Misdemeanor:** this is an offense for which the potential penalty does not exceed a fine of \$150.00 plus applicable court costs.
2. **Fourth Degree Misdemeanor (M4):** this is an offense for which the potential penalty does not exceed a fine of \$250.00 and possible imprisonment of no more than thirty (30) days or both.
3. **Third Degree Misdemeanor (M3):** this is an offense for which the potential penalty does not exceed a fine of \$500.00 and possible imprisonment of no more than sixty (60) days or both.
4. **Second Degree Misdemeanor (M2):** this is an offense for which the potential penalty does not exceed a fine of \$750.00 and possible imprisonment of no more than ninety (90) days or both.
5. **First Degree Misdemeanor (M1):** this is an offense for which the potential penalty does not exceed a fine of \$1,000.00 and possible imprisonment of no more than 180 days or both.
6. **Felony:** this is an offense for which the potential penalty exceeds a fine of \$1,000.00 and possible imprisonment is more than six (6) months (i.e. 180 days).

NON-WAIVERABLE OFFENSES (Must appear):

If the defendant has been charged with any of the offenses listed below (filed either under a state statute or municipal or village ordinance), for which the penalty exceeds a fine of \$150.00 or involves a possible term of incarceration or license suspension the defendant is required to make a mandatory Court appearance. Appearance is required, unless waived by the Court, pursuant to the Court's Local Rules, for the following offenses:

- Operation of a vehicle while under the influence of alcohol and/or drugs of abuse
- Consuming alcohol in a motor vehicle
- Reckless operation of a motor vehicle
- Having physical control of a vehicle while under the influence of alcohol and/or drugs of abuse
- Drag racing
- Leaving the scene of an accident
- Driving while under suspension/revocation of driver's license
- Driving without a valid driver's license
- Permitting an unlicensed driver to operate a motor vehicle
- Wrongful entrustment
- Fleeing and/or eluding an officer
- Failure to comply with an order/signal of an officer
- Exceeding 36 miles per hour in a twenty (20) mile per hour school zone during restricted hours
- **Exceeding the posted speed limit by more than 31 miles per hour in a 35 mile per hour zone, 45 mile per hour zone, 55 mile per hour zone, or 65 mile per hour zone.**
- **Four or more speed violations within a twelve (12) month period**
- **Three or more moving violations within a twelve (12) month period**
- Failure to stop and remain standing upon meeting or overtaking a stopped school bus
- Homicide resulting from the operation of a motor vehicle
- Registration violations (fictitious registration)
- Other offenses set forth in Ohio Revised Code Section 4507.16
- Altering and/or defacing signs
- Any offense for which the issuing officer designates that it is a mandatory appearance
- All drug offenses including minor misdemeanors
- Domestic violence
- Felony/indictable offenses (must be brought before the Judge without undue delay for initial appearance and bond hearing)

**BOND SCHEDULE FOR MISDEMEANOR CRIMINAL AND TRAFFIC OFFENSES
(STATE CODE AND MUNICIPAL ORDINANCES):**

Except as specifically noted herein or where it is designated as a mandatory appearance, or where the defendant has been released on their Own Recognizance, citation or upon summons, the following bail bond schedule shall apply:

First degree misdemeanors (M1):

State resident - Bond is hereby set at \$5,000.00 or ten percent (10%) thereof (i.e.\$500.00) and unsecured bond for the balance.

Out of State resident - Bond is hereby set at \$10,000.00 or ten percent (10%) thereof (i.e. \$1,000.00) and unsecured bond for the balance.

Second degree misdemeanors (M2):

State resident - Bond is hereby set at \$4,000.00 or ten percent (10%) thereof (i.e.\$400.00) and unsecured bond for the balance.

Out of State resident - Bond is hereby set at \$8,000.00 or ten percent (10%) thereof (i.e. \$800.00) and unsecured bond for the balance.

Third degree misdemeanors (M3):

State resident - Bond is hereby set at \$3,000.00 or ten percent (10%) thereof (i.e.\$300.00) and unsecured bond for the balance.

Out of State resident - Bond is hereby set at \$6,000.00 or ten percent (10%) thereof (i.e. \$600.00) and unsecured bond for the balance.

Fourth degree misdemeanors (M4):

State resident - Bond is hereby set at \$2,000.00 or ten percent (10%) thereof (i.e.\$200.00) and unsecured bond for the balance.

Out of State resident - Bond is hereby set at \$4,000.00 or ten percent (10%) thereof (i.e. \$400.00) and unsecured bond for the balance.

Minor misdemeanors (MM):

State resident - Bond is hereby set at \$1,500.00 or ten percent (10%) thereof (i.e.\$150.00) and unsecured bond for the balance.

Out of State resident - Bond is hereby set at \$3,000.00 or ten percent (10%) thereof (i.e. \$300.00) and unsecured bond for the balance.

NOTE: When a bondsman posts a surety bond for an individual they must post the whole bond; i.e. Bond is \$5,000.00 cash with 10% allowance. Individual could post \$500.00 (10%) **and sign bond for unsecured balance.** Bondsman must post \$5,000.00 surety bond.

The State of Ohio requires a \$25.00 surcharge to be added to bond(s) posted (including surety bonds) on or after October 16, 2009. Upon conviction, this fee will be forwarded to the treasurer of state to be deposited in the state indigent defense support fund. Fee will be returned if defendant is found not guilty or the violation(s) is/are dismissed.

MISDEMEANOR BOND SCHEDULE:

Defendants charged with waiverable offenses shall be informed by the arresting officer of the bond/waiver amount set forth in this schedule for the offense charged, of the right to pay the same by mail, in person, or by telephone with credit/debit card **BY THE COURT DATE**, and be provided an envelope for payment by mail. Bond(s) may be posted using a motorists' or travelers' organization card, that shows the complete address of the organization, by attaching the membership card to the original ticket to be filed with the Court.

All cases filed by the Sheriff's Office and Defiance Police Department are subject to ADDITIONAL costs of \$7.50


