Dear Ladies and Gentleman:

The Defiance Police Auxiliary had a very good year volunteering 1776.4 hours to the City of Defiance and working an additional 373.75 hours of projecting to cover for full time officers. This reflects an increase in the number of hours volunteered from last year and the projecting hours has shown an increase from last year as well.

The Police Auxiliary donated hours in areas such as sporting events, holiday parades, the 4th of July Fireworks event, and in-service training. They also assisted full time officers with their general duties and also area businesses with duties such as security, safety and training.

The Police Auxiliary began 2007 with a full 15 member roster with 2 members on medical leave. These two members resigned before they were able to contribute to the Auxiliary in 2007. The Auxiliary also lost 2 members to full time law enforcement positions one of which was hired by the Defiance Police Department. Another member is on current active military duty and one of our newest members has been in Peace Officer's Schooling since late August. For these reasons, the Auxiliary operated over half of the year with 10 officers.

Attached is a breakdown of officers' hours by activity. The headings; PATROL, TRAINING, PAID PROJECTS, PUBLIC RELATIONS, and ADMINISTRATION & MEETINGS are defined as follows:

PATROL- assisting full time officers with their duties. This includes, but is not limited to: traffic stops, complaints, accidents, traffic and crowd control, and court appearances. These are all non-paid hours.

PAID PROJECTS- all hours that an Auxiliary officer works for compensation. These hours are first offered to the full time officers and then to members of the Auxiliary. Examples of projecting include security at the mall, special school events, and sporting events.

TRAINING- any schooling the officer may take to further enhance his or her knowledge of law enforcement or to update their current standards. The most common training for an Auxiliary Officer is the Basic Peace Officer Training and qualification to carry a firearm.

PUBLIC RELATIONS- any detail that makes the officer visible in the community. This includes details such as manning information booths at the mall, fingerprinting children, and providing security at special events and parades.

ADMINISTRATION & MEETINGS- includes time spent in monthly or special meetings. This also includes special committees and report preparation.
